### RULES AND REGULATIONS

#### ELIGIBILITY CRITERIA

- The membership of Ludhiana Sanskritik Samagam ("LSS") is subject to scrutiny by the Membership Committee and approval of the Management.
- For membership to remain valid, annual fees must be paid on a calendar year basis; the fees shall fall due and be payable in advance on or before December 15th of every year, for the next year.
- The annual fees is subject to change from time to time. The revised fees, if any, shall be applicable to all existing and new members.
- The membership shall be non-transferrable, and all fees paid shall be non-refundable.
- In case of student membership, a recommendation from the School/College Principal must be submitted on a yearly basis; and the membership will be annual.
- In case membership is being sought under the Senior Citizen category, the form should be submitted along with age proof (any government issued ID).
- Temporary membership is only available for those individuals who are in Ludhiana on a transferable job on behalf of their company/department.
- Members other than those belonging to the Corporate Category shall be entitled to one (1) complimentary pass valid for two individuals for each event. Corporate Members shall be entitled to two (2) such complimentary passes for each event.

#### TERMS AND CONDITIONS

- The membership of LSS is subject to such terms and conditions as may be decided by the Membership Committee and approved by the Management from time to time. A member may be disqualified and removed from the list of members in case of violation of the rules and regulations / code of conduct of LSS.
- A Corporate Member shall cease to be a member if it is liquidated/wound-up.
- An individual shall cease to be a member if he/she becomes of unsound mind or becomes insolvent or is convicted of criminal offence involving moral turpitude or is in default in respect of any annual fee for a period exceeding three months from the due date.
- Any member may resign from LSS by giving two months' notice in writing to the President of his/her intention to do so, and upon the expiration of the notice such member shall cease to be a member of LSS.
